1. INTRODUCTION

What is the Barley Parish Plan?

In 2015 the first Barley Parish Plan was produced. The purpose of the Parish Council was to produce a plan that drew upon the collective views and aspirations of the people of Barley for their village; the intent being that the plan would be used to help inform the Parish Council about the wishes of residents, to assist in the identification of priorities for the village and to attract and direct resources appropriately.

The Plan is not intended to be prescriptive, but rather to focus attention on what matters to villagers, to identify their priorities and suggest how residents' enthusiasm for their village can be harnessed and encouraged. The Plan is also intended to give voice to debates with those bodies (either statutory or within the voluntary and charitable sectors) who can positively contribute, financially or otherwise, to the aspirations of the village.

Timeline

The first Parish Plan, after extensive public consultation, was published in 2015. The intention was to conduct the first review after five years. A new committee was established in Spring 2020 to start that review process, but its work was delayed by the Covid-19 pandemic. However, the committee has now reconvened and is starting that review process afresh.

• The way forward: first review

The Committee has reviewed what has happened over the last five years and how the previously identified village aspirations have been met. Please see Appendix 1 for a detailed update.

• Questionnaire

In tandem with the first review, the Committee compiled a new questionnaire (a copy is included as Appendix 2) to canvas the current views of villagers over a range of key topics, to allow the plan to be updated and to remain relevant.

2. SUMMARY OF QUESTIONNAIRE RESULTS

In the order of 269 questionnaires were delivered of which 111 were completed and returned, representing a 41% return rate.

- Don't believe NHDC come once a month
- Better maintenance of signage
- Pavement clearing & weed killing should form part of NHDC contract
- Why is Picknage Road left out of street cleaning
- Everyone should do own street
- Campaign to stop dropping litter

- Regular cleaning/clearing drains in winter. Smiths End often over flowing
- Footpaths often strewn with litter perhaps more signs
- Signs in lay-bys on Cambridge Road and Little Chishill Road saying where tips and bins are
- Street cleaning in Smiths End Lane does note exist it's a disgrace

- Concerned by mess caused by lorries carrying straw bales through the village – they should be sheeted
- Recently noticed increasing amount of litter in roads and pathways beyond village limits

5.4 Footpaths: What if anything would you like to see with regards improvements for footpaths and bridleways.

Comments:

- Owners need to cut hedges back regularly from footpaths and at junctions
- Regular cutting of hedges along lanes and footpaths
- Footpath to be created along Cambridge Road to Icknield Way
- Linking bridleway from Royston Road to Icknield Way
- Keep clear of nettles & brambles
- Improved signage & awareness of permissive paths
- More clearing particular in Spring
- Keep horse riders off footpaths
- More accessible paths for vulnerable users
- Replace bench at Smiths End Lan/Bogmore Road junction
- More footpaths going east
- Stockbank should be resurfaced fo cyclists very slow and risks of punctures

- Some field kissing gates need mending
- Green lane behind Doctors surgery up to Mount to be improved and cleared regularly
- Map of footpaths & permissive paths to ebb available eg on notice boards
- Leaflet of footpaths with map
- Footpaths to Barkway, Chishill & Royston
- Dog fouling penalty notices
- Ask Cokenach to allow filed paths
- Footpath from High Street to Plaistow needs attention
- Improvements to signage, seating & waste bins
- Map of walking routes leading to other villages
- Paths get very muddy in winter, some paths appear to be ploughed
- Aim should be 5-6 mile circular walk without using roads

- Hard-core to be laid on footpath form Pudding Lane to church
- Less dog fouling dog owner's to take more responsibility
- Keep benches free of undergrowth
- Keep paths clear of fallen trees and undergrowth generally
- Cutting back nettles & overhanging branches/brambles
- More barriers on road edge to footpaths to stop horse riding and cyclist
- Additional signage
- More dog poo bins Green/Drs Surgery, The Mount, at Bogmore Road at junction with path from horses field, Shaftenhoe End, High Street/Picknage Road junction, Church End: on all footpaths
- Hard-core infill to prevent muddy puddles at all gateways to horses field at Churchfields, also on the footpath to Nuthampstead by the wood with the pond
- Link Barley footpaths to Great Chishill permissive bridleways

- Should have surfaces on footpaths suitable for all year use
- Footpaths form The Chequers to The Fox and Hounds are poorly maintained & very narrow. Not good when pushing wheelchair/pram. Much of width has been lost under grass and encroaching hedges. Parts of High Street also bad.
- Footpath through the horses field to the cricket ground can be very boggy
- Surfaces on the footpaths in the village should be maintained so they are comfortable to walk on
- Would be really helpful if landowners ie Cokenach Estate did not use footpaths as roadways for their heavy vehicles. They have rights f way over the by-ways but not the footpaths. This often makes paths unwalkable

6. Further suggestions which have not been covered by this questionnaire or general comments:

- Danger of losing farmland to housing hope BPC will support local farms & fields
- Concerned at increase in HGV's more signage to say rods are unsuitable ruining verges, hedgerows and trees
- Promote environment through appropriate wild flora planting. We appreciate the importance of vehicular impact on the village but there is more to sustaining environmental impacts than cars
- Acute vehicle passing problems in Smiths End Lane. Make Smiths End and Shaftenhoe Road each one way
- Identify and make first aiders within the village for civil protection
- Identify safeguarding officer for village
- Barley could be greener EV charging & recycling
- Speed of traffic con London Road

- Parking a major issue encouraging more activities will exacerbate the problem
- Are Richmonds going to move?
- Will village shop leave before it has larger premises
- People should take dog poo home. Promote "stick & flick" along field paths
- Residents should be asked to clear over hanging trees & shrubs form footpaths
- More public parking Margaret House and Richmond's staff use too much on-street parking and Town House parking
- Next time add a "don't mind/don't have a view box to the questionnaire
- After last survey no follow up with people who expressed an

- Speed humps as per Fowlmere and Newton to address increase in speeding traffic
- High volumes of large heavy vehicles inc Richmonds buses needs to be addressed, together with parking especially on Church End and High Street
- Cleaning horse manure off roads
- Potential footpaths to Barkway and Chishill should include cycle ways
- Parking a big issue utilisation of old pig sheds?
- "Shop parking" designation outside shop
- Footpaths form Richmonds to the village shop are dangerous for the partially sighted
- Reduce verge cutting to safety areas only
- Steps to improve road safety & reduce traffic speed & potentially reduce the use of Barley as a short cut

- interest. Could all people who have expressed an interest in certain things be connected by email/door drop
- No bus shelters
- Volunteers could cut back tree & hedge growth that covers signs in the village, especially traffic signs
- Speed restrictions on Picknage Road
- Engage with local landowners to encourage greater access, possible through country stewardship schemes
- Who pays for more dog poo bins?
- Bulb planting to be combined with litter picking
- Keep Barley the hub & supportive village it is: stopping mass development
- Infill development in Barley like garage will see huge increase in traffic
- Compile a list of all residents who play games such as bridge, table tennis etc

3. MOVING FORWARD

It has always been recognised that in order to deliver any element of the Parish Plan, there would need to be engagement with a wide variety of organisations; but fundamentally it is essential for villagers to get directly involved, this is to turn many of the opinions and suggestions from this plan into live projects. The organisations that will need to be involved include statutory, discretionary and voluntary bodies, all having differing responsibilities, funding constraints and mandates, placing limits on the type of support they have been able to give.

The objective set by the Parish Council in 2015 for the Parish Plan, was for a document which drew upon the collective views and aspirations of the people of Barley for their village. The Plan has been used by the Parish Council to help identify priorities for the village, attract funding for projects and direct the limited resources available to it in the most appropriate way, and the Parish Council will continue to reference it going forward.

The Plan is in not intended to be prescriptive, but rather to focus on what matters to villagers and their main priorities. Once again through this review process the enthusiasm of Barley residents for their village has shone through. But this enthusiasm and goodwill absolutely has to be followed through by the villagers if the more challenging projects, whether in terms of effort or money are to be realised.

4. CONCLUSION

The Parish Council will have consideration of the findings of the Plan Review and will continue to utilise it as an aid to formal council decision-making, and where it is able, act as a facilitator to help support villagers in realising their aspirations for their village.

Traffic and safety: Key points to note:-

Speed Warning signs purchased.

BPC purchased a Speed Indicating Device (SID) in 2016. This equipment also acts as a Data Collector recording speeds, times and dates of passing traffic which is shared with the police for their consideration and possible action.

• Speed Camera Application.

As a result of lobbying by the old Speed Watch / DriveSafe team (Brian Haughey, Ian Turner, Nick White and Richard Emmerson), which has been backed up by the data from the Barley SID, the Office of the Police & Crime Commissioner (OPCC) and Hertfordshire Constabulary (HC) are considering the installation of a speed camera for a trial period, to identify persistent speeders. This is only to help reinforce the educational message from the OPCC's DriveSafe campaign and is not for enforcement.

Speed checks by the police.

Police manpower is still limited, but Barley is now receiving more speed checks and an overall higher police presence.

Liaison with police.

Liaison between BPC/Drive Safe and the Royston Safer Neighbourhood Team is very good, with regular conversations taking place.

ENVIRONMENTAL MATTERS – Climates change

Do you know how the climate of the UK is expected to change? By 2080 we could see:-

- Average summer temperature increase in SE England of 3.9%
- 23% decrease in average summer rainfall
- Increase of 16% average winter rainfall

We are already experiencing extremes in weather, and our small village is not immune. We cannot possibly deliver an effective Village Plan without including plans to tackle climate change.

The Barley Conservation Area covers much of the village and within it all trees are protected. In addition to which there are Tree Preservation Orders on other trees in the village. The Woodland Trust is advocating that we should go beyond this, and is strongly promoting the idea of communities and individuals taking responsibility for boosting the tree coverage of this country, which is now exceptionally low by taking local action. It suggests any tree felled be compensated by the planting of at least two, and preferably, three trees. There is also a policy for preserving flora in the churchyard and the Parish Council advocates for landscaping plans when consulted on planning applications. These are just some of the ideas that would help to make a positive change to our environment but there is more that each of us can do individually and collectively.

ENVIRONMENTAL MATTERS – Traffic and safety

- In the current Barley Village Plan, 75% of respondents were either worried or very worried about speed through the village.
- Since then, the Parish Council funded the Speed Indication Device (SID) that you will see being rotated around the village.
- Data has also been accumulated which shows that pre-Covid 19 speeds haven't reduced since the last Village Plan Questionnaire, with the top speed on High Street being 108 mph, 86 mph on London Road and 68mph on Picknage Road.
- Speeding has been a priority of the police for many years, but staffing levels have meant that the reality of speed checks and enforcement has been limited, although recently there have been more frequent enforcement checks and there is the possibility that this might be stepped up with visits from a Camera Safety

Van and other Speed Watch technology. The Speed Watch group along with the Parish Council will continue to actively work with the police do what is possible to reduce speeds.


